NON-PROFIT CORPORATION  
AMENDMENT OR CORRECTION TO BIENNIAL REPORT

The following information must be completed:

1. Exact Name of Corporation: As stated in the articles of incorporation, certificate of authority or most recent amendment.
2. Year of Biennial Report to be amended or corrected. A separate form and fee must be submitted for each Biennial Report to be amended or corrected.

Only complete the following information being amended or corrected:

3. Officers and/or Directors: Indicate if you are replacing, adding or deleting the officer and/or director. Give name, title and complete address for each.
4. Principal Office Address: Complete street address required.
5. Nature of Business: Provide a description of the nature of business conducted in Nebraska.

The following information on the biennial report cannot be amended or corrected on this form, but may be changed by filing the designated form below:

Registered Office and/or Registered Agent: You must file the Change or Registered Agent and/or Office form found on our website at [http://www.sos.ne.gov/business/corp\\_serv/corp\\_form.html](http://www.sos.ne.gov/business/corp_serv/corp_form.html). This form may be uploaded and filed online using the Corporate Document eDelivery.
