Chapter 4 - Wildlife Regulations

006 Coots, Ducks, Geese, Crow

The following regulations are prescribed by the Game and Parks Commission, State of Nebraska in accordance with Neb. Rev. Stat. §§ 37-314, 37-315, 37-405, 37-411, 37-428, 37-501, 37-508, 37-536, 37-563, 37-701. For purposes of these regulations, unless context otherwise requires, the definitions found in Chapter 37, sections 202 through 247 of the Game Law, are used. These regulations are effective following enactment by the Commission, approval by the Attorney General and Governor, and when five days have elapsed since filing with the Secretary of State.

006.01 HUNTING SEASONS

006.01E Crow - Public Nuisance/Health Hazard Order

<u>006.01E1</u> In Buffalo, Dawson, Franklin, Harlan, Kearney, Lincoln and Phelps counties, the crow is concentrated in such a manner and number as to constitute a public nuisance and a health hazard and may be taken using methods authorized during firearm and archery seasons during the period November 16 through January 19 in addition to the regular hunting season dates. Shooting hours shall be in accordance with the regular crow hunting season as specified in regulations. None of the birds taken pursuant to this section, nor their plumage, shall be sold or offered for sale.

006.01F Youth Waterfowl Hunting Season

006.01F1 Eligibility: Youth 15 years of age or younger. Youth ages 12 through 15 must be accompanied by an adult at least 18 years old. Youth younger than 12 must be accompanied by an adult at least 19 years old who possesses a valid Nebraska Small Game Permit. In neither case, the adult will not be allowed to shoot ducks, geese, mergansers or coots.
